Valley Fire Hit Home

The Valley Fire in Lake County reminds us of this fact. One thousand two hundred eighty homes plus hundreds of other structures were destroyed. Many residents had THIS FIRE HIT

only minutes to evacuate their homes.

This fire hit very close to home, literallyour family's vacation home is in the area. Many of my neighbors and friends lost their homes and all of their belongings. I was one of the fortunate ones-my home suffered very little damage. One of my neighbors, 90 years of age, was lying in bed reading a book when she received a call to evacuate. She had only minutes to escape and was only able to

grab her purse and carry her shoes before a deputy sheriff whisked her away. Unfortunately, her home was completely destroyed.

I know that this is only one of many such stories, and it will take many months for these families to rebuild their lives and homes as they contend with issues such as the removal of hazardous waste from their properties. Lessons learned from this disaster will help refine our own planning for a major earthquake or fire in Contra Costa, particularly around mass shelters for those who may lose their homes and possessions.

Mutual Aid to Our Neighbors

I was very proud of our Medical Reserve Corps, who were called upon to provide medical assistance in the temporary shelters and ongoing clinics in Middletown, and our Behavioral Health team, who also responded to requests to assist fire victims experiencing psychological trauma. All of the preparation that we do as a County keeps us and our emergency response partners ready to

respond not only to disasters in our County, but those of our neighbors when we are called upon for mutual aid.

Get Prepared

During times of disaster, resources are tested and emergency personnel may not be able to respond to everyone in need immediately. Personal emergency preparedness is essential. One thing I heard from many of the victims of the Lake County fires was they wish they had been better prepared. We should all take the time NOW to ensure that we have planned well to keep

our families and ourselves safe during emergencies. Please refer to the guidelines on personal preparedness on our website.

As Disaster Service Workers, you are mandated to report to work during disasters and help those in need. You won't be able to do this effectively if you and your family are not safe.

Free flu vaccine will be provided to employees who need to be vaccinated to comply with the Health Officer order (all employees involved in direct patient care or in patient care areas must receive a flu vaccination or wear a mask). New Program Covers County Residents Ineligible for Health Insurance

The Board of Supervisors voted last month to establish and provide \$500,000 funding for a new pilot program called Contra Costa CARES. This program will provide primary care to undocumented adults who are ineligible for Medi-Cal or Covered California. Local hospital boards have also approved a combined total of \$500,000 to help fund the Contra Costa CARES program. This combined County and community hospital funding will provide care for approximately 3,000 adults. CCHS Director Dr. William Walker said he hopes the state or federal government will eventually provide a permanent Sept. 22 Board of Supervisors meeting. funding source for the program.

The program was developed through an extensive planning process representing many local stakeholders over the past year with leadership provided by Contra Costa Health Services, Hospital Council of Northern & Central California and the Community Clinic Consortium of Contra Costa, including representatives from Kaiser Permanente, Sutter-Delta Medical Center, John Muir Health, La Clínica de la Raza, LifeLong Medical Care, Brighter Beginnings, and Planned Parenthood. The planning process was funded by grants from the Blue Shield of California Foundation and John Muir/Mt. Diablo Community Health Fund.

Contra Costa CARES may begin operating as early as November. Contra Costa CARES participants will access primary care services, including basic laboratory and radiology services, at La Clínica, Lifelong, Brighter Beginnings and Axis Health Care. Specialty care, dental, vision, emergency care and hospitalization won't be covered under the program.

In 2009, in the midst of a recession, the county stopped providing health care coverage for undocumented adults. Dr. Walker said Contra Costa CARES will save the county money because it will deter people from relying on county emergency rooms for primary care.

CCRMC Re-Opens Parking Circle

Contra Costa Regional Medical Center (CCRMC) recently re-opened the parking circle in front of the hospital's main entrance to make it easier to drop off people or pick them up. The circle is currently open from 7 a.m.-5 p.m., Monday through Friday, with the hopes of expanding to include weekends and longer hours during the weekdays. The circle, which had been closed off after 9/11 for security concerns, was re-opened following a three-day pilot in May, which elicited overwhelmingly positive feedback from patients, families and staff. During the pilot, 88 people were counted dropping off patients or picking them up. Those surveyed resoundingly supported permanently re-opening the circle to traffic, citing the improved convenience.

Medi-Cal Drug Waiver to Expand Treatment Options in Contra Costa

Recent changes to Medi-Cal rules have dramatically expanded Contra Costa County's ability to refer and cover patients who need treatment for substance use disorder (SUD), and the Behavioral Health Division has begun its public planning process to meet the anticipated need. Contra Costa will be among the first California counties to implement the Section 1115 Medi-Cal Demonstration Waiver that expands SUD treatment, including residential and medication-assisted treatment, to all Medi-Cal beneficiaries by referral from their medical providers. Medi-Cal has historically provided limited residential treatment coverage exclusively for pregnant or postpartum patients. The 12 Bay Area counties will be among the first to implement the waiver, and all are required to use community engagement processes to prepare implementation plans showing how they will create organized

systems of care to serve their communities. Alcohol and Other Drugs Services (AODS) kicked off that process in September with a series of community planning meetings.


Kennedy High School Clinic Now Open to Community

Our school-based clinic at Kennedy High School in Richmond is now offering pediatric appointments and dental services to community members. Medical services are available from 1 p.m.–5 p.m., Monday through Friday. Parents can schedule medical appointments at the clinic by calling our Appointment Unit at 1-800-495-8885. Like our other pediatric clinics, the Kennedy High clinic offers well-child exams and sick visits. Dental services are available Tuesdays from 8 a.m.–4 p.m. and include exams, x-rays, cleanings, preventative care and fillings. Dental appointments are scheduled by dental staff at 510-730-9625. The school-based clinic, which is managed by Public Health Clinic Services, opened in February 2015. It initially only served Kennedy High students two mornings each week. In April, the clinic added pediatric dental services and this summer it began offering pediatric medical services to the community five afternoons a week.

Public Health Releases Report Projecting Community Risk from Climate Change

In future years Contra Costa County will experience more heat waves of longer duration because of climate change and should prepare for associated health impacts, according to a report recently released by Public Health's Epidemiology, Planning & Evaluation (EPE) Unit and Climate Change and Health Working Group. "Climate Change Vulnerability in Contra Costa County: A Focus on Heat" predicts more annual 100-degree days across the county and a range of climate-related health impacts, including worse air quality, increased risk of wildfire and an increase in certain allergens and infectious diseases.



This map from the report shows that many cities in Contra Costa contain areas with very little continuous tree cover to provide cooling shade.

The report identifies low-income communities, non-English speakers, people with pre-existing health conditions, the very old and the very young among those particularly vulnerable to climate-related health issues, and it recommends coordinated community planning and public education. The report was partially funded by the California Department of Public Health's Office of Health Equity and the Centers for Disease Control and Prevention.

Staff Encouraged to Take LGBT Client-Centered Training

In order to maintain and enhance our standing as a designated national leader in the care for Lesbian, Gay, Bisexual and Transgender (LGBT) patients and clients, more CCHS managers, supervisors and staff are being encouraged to take free training sessions on LGBT best healthcare practices. In 2013 and 2014, our Contra Costa Regional Medical Center (CCRMC) was recognized as a leader in healthcare equality by the Human Rights Campaign (HRC), the largest national organization advocating for LGBT rights. This year, the goal



is to obtain the healthcare equality designation for others in Health Services in addition to CCRMC, including the West County Health Center, Behavioral Health and Public Health. HRC's trainings are available online through the Center for Affiliated Learning. The required courses in the training series take from one hour to three-and-a-half hours to complete. The purpose of participating in the trainings is to increase accessibility and quality of care for LGBT patients and family members.
