Judy Bastin stated that she is representing the Master Gardener's program and Support4Recovery. She reported that the Master Gardeners have created the Seeds4Recovery program and they have two garden beds ready to be planted and hope to attract people within the treatment system. Seeds4Recovery will be sponsoring the viewing of the film "Seed the Untold Story" in Antioch on March 23<sup>rd</sup>.

- Tom Aswad reported that the Seeds4Recovery program is a great opportunity for alumni to connect with Support4Recovery. He also stated that Support4Recovery is adding a new program entitled Support4Education which replicates the work currently done in San Quentin out in the community.
- Doug Sibley reported that he met with three Native American people from the United Urban Warriors Society. They are planning their 3<sup>rd</sup> annual Sobriety Walk in Richmond in July. They would like to present to the full Board in April to invite them to attend the walk.
- Anthony Segovia introduced himself and stated that he was born and raised in Brentwood and that he joined the Board because he has friends who suffer from addiction and he would like to raise awareness in East County about Substance Use.
- Michael Collins introduced himself and stated that he is a Registered Nurse working in Sacramento and lives in Oakley. With his experience as a nurse he has had a lot of exposure to people who selfmedicate which got him interested in the Board
- Gary Eberhart introduced himself and stated that he lives in Concord and has worked on the Mt. Diablo School Board of Education. He is interested in addiction and recovery and its relation to students and their education.
- Antwon welcomed the three new Board members to the Advisory Board.
- Isabelle Kirske reported on the Dose of Awareness Walk scheduled for Sunday March 26<sup>th</sup> from 1:00pm – 3:30pm located at 901 Oak Grove Rd. in Concord at Ygnacio Valley Park.
