Contra Costa County COVID-19 Congregate Care Team is dedicated to protecting highly vulnerable seniors from COVID-19 infections and deaths. Skilled nursing facilities and residential care facilities have accounted for nearly two-thirds of the county's COVID-19 deaths. This has prompted a powerful coalition in Contra Costa County to kick start a rapid infection-control curriculum and learning community for the skilled nursing facilities. Through partnerships with local hospitals, community, advocacy groups, and local facilities we have developed custom training and tailored best practices to help local operators care for community elders in sensitive facilities on the front line of the pandemic.
