Description: California Children Services (CCS) is a statewide program that arranges and pays for medical care, equipment and rehabilitation for eligible children and youth. Services can be authorized for children and youth adults under 21 years of age who have eligible medical conditions (such as congenital heart disease, sickle cell anemia, cystic fibrosis, cleft palate, and HIV infection) and whose families are unable to pay for all or part of their care. CCS determines eligibility and selects the most qualified professionals to treat each child's CCS-eligible condition.

A child may be eligible for CCS if she or he meets all of the four following criteria:

1. Age - The child must be under 21 years of age.
2. Residence - The child must be a permanent California resident.
3. Family Income – The child's family income must meet one of the following criteria.
  - Be less than \$40,000 per year (adjusted gross income as reported on California State income taxes) – OR
  - If greater than \$40,000 a child may be eligible if medical care for the CCS-eligible condition is expected to cost more than 20% of the family's income.
  - EXCEPTION: Income is not a factor in determining eligibility for the

medical therapy program. Eligibility for the medical therapy program is based on medical condition and clinical findings.

4. Medical Conditions – Only certain conditions are eligible for CCS. See website for more information. In general, CCS covers medical conditions that are physically disabling or require medical, surgical, or rehabilitative services.
5. Even if a child has private insurance, she/he may still qualify for CCS.

- Social Security Disability Insurance (SSD) benefits are paid to disabled worker or his/her family when the worker becomes so disabled that s/he is unable to work. The disabled worker must have worked in employment covered by Social Security.
- Supplemental Security Income (SSI) makes monthly payments to aged, disabled and blind people who have limited income and financial resources. This benefit is not just for adults. Children who are blind or disabled are also eligible depending on family income.
- Social Security for Children: Benefits are paid to the child of a deceased, disabled or retired worker if the child is under 18 or between 18 - 19 and attending high school. Benefits are payable to a disabled child of a disabled retired or deceased worker at any age if the child's disability began before age 22.

The Social Security office is the general information source for Medicare benefits.
