**SMALL WATER SYSTEM FEE SCHEDULE
 Effective February 4, 2014**

In order to obtain approval for installation or repair of any system, the following fees must be paid prior to any inspection or investigation of an individual parcel or minor subdivision.

Permit fees include a non-refundable \$39.00 application fee. Inspection and travel time exceeding the hours provided in the service fees set below or provided for services not listed will be charged at the rate of \$174.00 per hour during normal business hours and the rate of \$224.00 per hour after normal business hours. Services provided after normal work hours will be charged \$224.00 per hour above and beyond the cost of the permit.

Ordinance Code of Contra Costa County Section 414-4.1019

Enforcement – Penalties. Any person violating this chapter or regulations issued hereunder, by failing to submit plans, obtain necessary inspections and approvals, or pay fees, or by commencing or continuing construction or remodeling in violation hereof, shall pay triple the appropriate fee as a penalty and remain subject to other applicable penalties and enforcement procedures authorized by the state law and/or this code.
