

## Operations and P&P SLR surveys

### Introduction

The Contra Costa County Hazardous Materials Commission is an advisory board to the Contra Costa County Board of Supervisors made up of representatives from cities, businesses, environmental groups, labor, and others.

Based on State guidelines that predict a x% chance of x feet of SLR by 2030, the Commission is concerned about the potential impact of future sea level rise caused by climate change on the transportation, storage and use of hazardous materials in areas of the County near the shoreline susceptible to flooding.

The Commission is conducting this survey to better understand the interests and concerns of others so that they can better advise the Board of Supervisors about what actions to take to address the impacts of sea level rise.

*On a scale from 1 - 5 with 1 being not at all interested and 5 being very interested*

*On a scale from 1 - 5 with 1 being no activity or actions at all and 5 being significant activity.*
