**Sharps** are syringes, needles and lancets.

They must be disposed of properly to prevent the injury of others and the spreading of germs.

<p><b>Sharps SHOULD NOT be:</b></p> <ul style="list-style-type: none"> <li>• Placed in recycling containers</li> <li>• Flushed down the toilet</li> <li>• Thrown in the garbage</li> </ul>	<p><b>Sharps SHOULD be:</b></p> <ul style="list-style-type: none"> <li>• Placed in a hard plastic container</li> <li>• Taken to a drop-off collection site</li> <li>• Taken to an accepting pharmacy</li> </ul>
