 - b. Complete the online training through the Praed website. Instructions are available here: https://cchealth.org/mentalhealth/pdf/CANS-Online-ReCertification-Instructions.pdf
- 2. When creating an account, ensure staff:
 - a. Select the correct agency followed by "- Contra Costa County".
 - b. Enter their work email. Please emphasize the importance of this step. If not complete, certification will not show up in Objective Arts and user will not be able to create a CANS.
 - c. Remember their user name and password

*If staff do not do complete steps a-c above accurately, they must log in and edit their profile with the correct information as directed above. To edit profile, once logged in, staff can hover over "Me" on the left hand corner and select "My Profile." To change agencies, staff must email support@schoox.com

3. Organizations may also choose to identify staff (i.e. clinical supervisor, program manager, and training director) to become "In-House" Agency CANS Trainers. These staff must attend a "Trainthe Trainer" workshop led by Praed facilitators.

CLIENT EPISODES: Only current client episodes will be transferred from ShareCare into OA

- 1. Client Episodes are current in ShareCare
 - a. Once in ShareCare go to Main Menu→ Clinical Report→ Admissions
 - b. Select the Caseload tab
 - c. Enter your facility and program information, and select "View Report".
 - d. Organizational units are accurate (Only episodes with active OUs will be transferred into OA.)
 - e. Episodes are closed if appropriate
 - f. Primary Service Provider assigned is active

STAFF & ORGANIZATIONAL UNITS: Active agencies and staff will be transferred from ShareCare into OA.



- 6. System Administrator has reviewed and verified staff CANS certifications in OA.
 - a. A master list of certifications will be uploaded into OA after all staff accounts have been verified in the Production site. Afterwards, recent certifications will be automatically transferred into OA from schoox.com on an ongoing basis.
 - b. For any staff who are missing a certificate:
 - i. Verify that the staff has a current certificate from Schoox.com.
 - ii. If staff received their CANS certification prior to having an account created in OA, their certificate may not have transferred.
 - iii. System Administrator may add the certificate manually with the appropriate expiration date or email CCBHS.

C. Creating Assessments

The easiest way to create an assessment is to click on "Workload" Here you will see a list of clients who are assigned to you.



- Double click on Client's Name > Click + New Assessment and the CANS or CANS 0-5 will auto appear based on your client's age > Click on
 > and begin
 - Fields for Client ID, Client Name, Assessor, Date of Birth, Client Gender will auto populate. Disregard field Entered By.
- Field "Assessment Date": This will auto-populate today's date and is the date that Assessment was first created.

 You are allowed to edit this date before hitting

 → Submit
- Enter "Org Unit": Enter the facility program number for the client from the drop down list. Assessment won't save if an OU is not chosen.
- Go to Assessment Information and choose from:
 - o *Initial*: First due when opening case (within 60 days of Episode Opening Date)
 - o **Reassessment**: At 6 month mark or Annual (due by the end of the 5th month for 6th month mark or 11th month for annual)

- Update (Initial or Reassessment): When you have already submitted an Initial or Reassessment but need to make changes to that prior assessment. This falls out of the "6 month" or "Annual" mark. Reasons for an update may include clinically significant changes that have occurred in client's life. Include narrative in next box (i.e. "Client was hospitalized for danger to self at Willow Rock" or "Client entered Juvenile Hall." Or "Client was removed from mother's care and now in foster care."
- Discharge: When discharge is planned with client and/or caregiver
- o Admin Discharge: When discharge is unplanned (i.e. client has been no-showing despite outreach efforts, etc. or clinician has not been able to communicate with client). In this case, you will complete the CANS to the best of your knowledge or copy data from the most recent CANS done with the client.
- If you are ready to finalize and submit the Assessment, hit and refer to Section E.
- If you need to return to the Assessment and complete another day, hit refer to Section D. ▲ Save

Editing Assessment (i.e, once you've already hit

once)

You can access assessments "in progress" two ways:



- 1. From the Dashboard/Home Page, click on Workload
- 2. Click the "Data Portal" icon and then at the top of the screen using the "Assessments" tab. Select from the drop down list "My In-Progress" and all the Assessments that have been started but not yet completed and/or approved will appear there as one of three things: Assigned or Submitted. Once it has been approved, it will appear as "Approved by..."
- Identify which client you need to work on, double click on client's name and the saved Assessment should appear with the saved data
- Hit 🕑 Edit on the bottom right and you will able to enter data
- Scroll all through the Domains to ensure that required items are scored, including the extension modules **Tip**: Required items are marked with an asterisk*



Dashboard

To view Dashboard, hit Home at any time.




Entering Data

- ✓ Enter data by clicking on bubbles or using the Tab button on your keyboard to enter numbers
- ✓ Click on Add Note if you would like to enter narrative

Extension Modules

✓ Extension Modules are **required if triggered by a score or 1, 2, or 3** on the corresponding core item. Leave these modules blank if the trigger item is scored 0. You will know which items trigger an extension module as they have a ('module abbreviation') next to them:



Pre-Populate

✓ Once an assessment for a client exists in OA, you will be able to use the data entered from a previous Assessment by hitting the Pre-Populate button. If you hit Pre-Populate it copies the scores from the previous assessment to the new assessment, so you don't have to worry about overriding the previous one.



✓ You are able to pre-populate an assessment that was completed by another clinician and/or from another reporting unit.

Miscellaneous

- ✓ Google Chrome is the recommended browser.
- ✓ Your OA user name is always your work email (the email used to register on Schoox).
- ✓ Save periodically. OA system DOES NOT save automatically. Users must do this on their own.
- ✓ If inactive after 30 minutes, you will be logged off automatically. If you are doing an assessment and leave the window open and have not saved the assessment, you may lose it! Please save at least every 15 minutes.
