

- 0830 Cal OES spill report number 17-4993 received by CCHS-HMP. Workers at the Union Pacific Ozol Rail Yard at the end of Embarcadero Street in Martinez reported an odor coming from an empty railcar that last held sulfuric acid a Hazmat Manager from Union Pacific was currently en route. Specialist X. Bryant of CCHS-HMP contacted Union Pacific by phone.
- 0913 Specialist I. Williams and Specialist S. Heller departed the CCHS-HMP office in Truck HM1.
- 0925 HM1 passed Engine 14 of CCCFPD departing the scene.
- 0926 HM1 arrived on scene at the Union Pacific Ozol Rail Yard at the end of Embarcadero Street, Martinez, CA 94553.
- 0930 CCHS-HMP met with the rail yard manager, Dave Spiro. A constance of the railcars was provided. Workers near railcar GATX 6304, containing spent sulfuric acid had noticed a sulfur odor. The workers also noted that they had a history of problems with the next in line railcar, UTLX 68003, containing spent sodium sulfide solutions. A Union Pacific haz mat team member, Paul Holt, was currently en route to the rail yard, with an estimated time of arrival of 1000. The three North tracks had been shut down. A strong breeze out of the West was observed.
- O938 Specilaist 1214 and 1222 conducted ground level air monitoring, approaching the suspected rail cars slowly from the East. A PID/LEL meter, 4-gas CGI meter, Sulfur Dioxide gas badge, and a Hydrogen Sulfide meter were used. All air readings were normal- CCHS-HMP did observe an intermittent odor from upwind.
- 0955 Air monitoring at ground level complete. All readings normal.
- 0957 CCHS-HMP met with CCCFPD B.C. Ciotola.
- 1000 Paul Holt of Union Pacific Railroad arrived on scene.
- 1015 CCHS-HMP and Mr. Holt climbed car GATX 6304 and inspected the protective housing and fittings. All air monitoring readings were normal on both the CGI and PID/LEL meters. While on the car, the group observed an intermittent propane/natural gas odor from upwind. The group exited to the rail office and prepared to inspect the flammable railcars upwind and identify the origin of the chemical odor.

REPORT:

- 1040 CCHS-HMP and Mr. Holt began inspecting the flammable railcars upwind. FR PPE used.
- 1110 The source of the odor was located within the protective housing of car PLMX 135588. The car placard read UN 1075, and the constance read Isobutane - 'Previously Contained'. The LEL readings were noted as high as 600ppm near the pressure relief valve. Readings in the breathing space were normal. Snoop was applied to the PRV housing, and bubbling was observed between the housing and the car deck.
- 1130 Safety meeting held.
- 1145 The four flange bolts at the base of the PRV were alternately tightened down using a crows-foot wrench. Snoop solution was applied and there were no further visual signs of bubbling. The entry team continued air monitoring - all readings normal within the protective housing and in the surrounding breathing space.
- 1155 The entry team exited the railcar and returned to the rail office to brief site personnel and CCCFPD.
- 1210 CCHS-HMP packed up equipment and departed the scene in HM1.
- 1225 HM1 arrived at the CCHS-HMP office and rehabbed the HM1.
- I. Williams of CCHS-HMP to coordinate with Paul Holt regarding any incident follow-up.
