

REPORT:

CCHSHMP received a notification from ConFire Dispatch that a semi had overturned on the Highway 4 on ramp at I-80W and was on fire and leaking diesel. The responding BC was identified as Darren Johnson (925-457-0358). HMS Dwight attempted to contact BC Johnson to obtain more details but was unable to make contact, so HMS Dwight and Duazo departed for the scene in HM3 at 12:17 PM.

HM3 arrived on scene at approximately 12:45 PM and observed a semi on its side that had been carrying a load of crushed cars. The cars towards the back of the truck had caught on fire. Rodeo/Hercules Fire had responded and put the fire out. The semi had a 100 gallon saddle tank that had not ruptured; a small amount of spilled diesel and automotive fluids appeared to have been from broken hoses. This was mixed with fire suppression water. Rodeo/Hercules Fire had also dammed off the closest storm drain. Cal Trans personnel were on site and indicated they would handle the clean up.

HMS J. Pham and A. Springer arrived on scene in HM4 at 1:24 PM. HM3 departed the scene for another response at 1:29 PM. HMS J. Pham and A. Springer remained on scene to observe the uprighting of the semi and to ensure additional diesel was not spilled. HM4 departed the scene at 2:57 PM.
