**NOTE:**

- Second re-inspection of verified complaints will be charged to the property owner/responsible party.
- A \$199.00 fee will be charged for verified complaints at permitted and fee exempt facilities.
- Additional charges will be incurred after the minimum hourly charges have been expended. Services provided after normal work hours will be charged at \$224.00 per hour, above and beyond the cost of the permit.
- **Penalties:** Penalties will be imposed for delinquent payments as provided in County Ordinance No. 93-58; Article 413-3.1206
