Several people were suggested for the interview panel: someone from the Agriculture Department, Public Works, and HazMat; someone from another county; a member of the IPM Committee, Michael Kent, Gretchen Logue, or Andrew Sutherland.

6. Hear reports from the Decision-Making and Outreach Subcommittees

Andrew Sutherland reported that the Decision-Making subcommittee is seeking clarification of current pest management activities. Andrew has a meeting with the Public Works Department to discuss their presentation to the Transportation, Water and Infrastructure Committee.

Michael Kent reported that the Outreach subcommittee will not meet until a new IPM Coordinator is hired.

7. Hear reports from the Agriculture and Public Works Departments

Larry Yost reported for the Agriculture Department.

• The Department is three-quarters of the way through their noxious weed treatments on artichoke thistle and purple starthistle.

• They are managing weeds for East Bay Regional Parks, Mt. Diablo State Park and private ranches that pay for the service.

Brian Louis reported for the Public Works Maintenance Division

• They currently have no one on staff with a Pest Control Advisor's license, so they cannot do any pesticide treatments along roads or flood control channels.

The Committee and the public suggested that this is a perfect time for the Public Works Department to evaluate not using herbicides.

8. <u>Determine members of the Vegetation Management Forum Task Force</u> Gretchen Logue and Larry Yost volunteered.
