- 1. Review of Elderly Homeless Report
 - a. Strategic plan objective to gather data on the needs of our elderly homeless population
 - b. Looked at visit level diagnoses for HCH elderly homeless seen during 2018
 - c. Presented findings on the five most common diagnoses seen among the population, and HCH activities to address patient needs
 - d. Question from Board Members: How do we see the needs of this population changing if the hotel placement program comes to an end?
 - i. Believe the hotels have supported patients in connecting to care and managing chronic illnesses
 - ii. Need further evaluation to understand true impact of hotel program on patient's health and utilization. Findings could support future funding opportunities.
 - e. Board member shared efforts of CORE to connect hotel residents to permanent and supportive housing
 - f. Question from Board Member: Is there a need for further funding or partnerships to support the delivery of healthy foods to the hotels?
 - i. Currently meals and snacks provided through a variety of different vendors
 - ii. Will look further into how potential funding for food delivery could support patient population
 - g. Question from Board Member: Are the hotels currently supporting a large portion of the elderly homeless population?



i. We are prioritizing placement of older adults and those with health conditions that make them more susceptible to poor outcomes from COVID.
