<u>Welcome and Introductions:</u> Rosa welcomed everyone to the second hybrid meeting of the year at 10:01AM. Guests attending on Zoom were asked to enter their names and affiliations in the Chat for attendance purposes.

Vi took roll call and determined quorum was established.

The meeting minutes from March 22, 2023 were approved unanimously and without corrections (m/Nickole B., 2<sup>nd</sup>/Suzanne A.). There were no additions to today's agenda.

#### **UPDATES:**

# RCEB Report by Lisa Kleinbub, Executive Director:

Lisa commented that April has been quiet in the world of I/DD. She reported on the following:

Today at 1:30PM, there will be an Assembly hearing on the Little Hoover Commission and Georgetown reports. The commission is looking at oversight changes in the I/DD system and how Regional Centers can be consistent across the State. For instance, they are looking at differences in service access across various backgrounds such as ethnicity as well as across Regional Centers.

Also, RCEB continues to have challenges with having enough case managers. They are holding a job fair at the San Leandro office today with a focus on case management

recruitment. They need to hire about 80 positions over the next month. A more enhanced training program is being offered to candidates that might not have as much experience with the Regional Center system as others. Lisa notes that funds have been made available to reduce caseloads, however, many people have moved out of the area which has contributed to the staffing challenge.

# Comments from the President of the RCEB Board - Frank Paré

Frank extended gratitude on behalf of the Board for the invitation to speak on a few items today. He is a parent of a 27-year-old daughter who is a client of RCEB, and has gotten more involved in advocacy work not just for his daughter but also for others. He joined the RCEB Board three years ago without the intent to become President and is honored to represent them. Frank was invited to share information about the RCEB Board.

There are currently 14 board members - they can have up to 20 and so they are actively recruiting. The board is required to have 50% of membership filled by individuals with I/DD or who are parents/guardians, and at least 25% are to be clients of the Regional Center. There are several advisory committees including PVAC, the SDP local advisory, Community Advisory, and Diversity and Equity committees. If you are interested in the committees, you are encouraged to attend the Board meetings.

The role of the Board is to determine what can be better. Lisa K. is their sole employee who navigates what is happening in Sacramento and in the community. Sometimes parents bring issues to the Board to identify blind spots and to try to figure out ways it can be addressed. For families feeling a lack of service, it can impact their lives to a large extent. The Board tries to figure out whether it is a one-off situation or if it is a systemic issue, and how to make it better.

Sadia Mumtaz, Vice-President of the RCEB Board, is the co-chairperson of the Diversity, Equity, and Inclusion Committee. Sadia has been on the board for a 1.5 years and has a child with I/DD. Her son was born in Boston and the family tried to live in Pakistan but found there were not a lot of inclusive services.

Sadia and Frank are exploring how to bring about changes related diversity and equity brought forth during the public comment periods of their meetings. The Diversity and Equity committee has several new initiatives, including:

- advocating policy changes if needed from the bottom up level
- ensuring access for families whose primary language is not English
- training families and consumer about their rights

Additionally, they are looking at the flow of board meetings to make sure there is more time to discuss issues and get perspective from members. Legal issues are discussed during closed door sessions.

Consumers, families, and others interested in the work are encouraged to attend one of the monthly Board meetings. The next meeting is on May 22<sup>nd</sup> from 7-8:30PM. You can

Vi added that both Alameda and Contra Costa Counties have committed to resuming in person in 2024, and they are also looking at ways to increase accessibility to community.

After giving both locations a try, the Council can decide if one works best or consider another location. Meeting locations must have enough room, decent technology, adequate parking and be accessible to the community.

### **Committee Liaison Reports:**

# Mental Health Commission – Pam Perls

Pam reported being busy with various meetings and committees. Their quality-of-care committee is looking at mental health in schools K-12 - there is no data out there! The County will be doing a 4-district project focused on communities that have the most kids where English is the 2<sup>nd</sup> language (Antioch, Pittsburg, West County, and John Swett account for about 60% of students in the County).

The justice committee is trying to get cooperation from the Board of Supervisors, focusing on mental health facilities in the newly expanded jail and finding out about youth programs. Lastly, Pam learned the "BHBH" project - Behavioral Health Bridge Housing program - includes the I/DD community as well. BHBH grant applications are now open for funding that will go towards housing needs for people that are homeless and have mental health diagnoses.

Stephen suggests the Council look into how the County is handling these processes, and consider training on supported decision making that passed last year under AB1663.

## Comments/Questions

- A question was asked if a family can go to court to obtain conservatorship without the person being conserved being notified? Stephen clarified that a family can file a petition without the person's involvement, but otherwise the person would be notified and expected to be involved with the court proceedings.
- Vi proposed as next steps for interested board members to observe court proceedings, with Steve's help in facilitating that. Ideally, board members would observe before the August annual planning meeting.
