CCH Chair introduced new community member added to the oversight committee, Kent Hull

CCH Health Officer Dr. Sefanit Mekuria provided the committee and public an update on the county's health advisory to not eat produce grown in personal gardens in the Martinez area until results of the Risk Assessment are completed. Health Officer noted that the advisory has been created out of "an abundance of caution" and stated that no immediate health concerns are known.

Public Comment (2 minutes each) on the Health Officer announcement. A total of 16 comments were received. Main concerns presented by members of the public:

- Concerns about the length of time it took for the advisory to be announced, many were already eating the produce from their gardens in the months following the incident
- Concerns about the safety of the water supply for the Martinez area
- Comments about the need to improve the process of informing members of the affected community that the advisory had been made
