CCHP Announces New Online Search Engine (OSE)

The CCHP Online Search Engine allows members, potential members, providers and health services staff the ability to look up the over 1300 CCHP Primary Care Providers, Contracted Specialists, Facilities (X-Ray and Labs, Imaging Centers, Contracted Hospitals) and Pharmacies in the Greater Contra Costa County Region.

The OSE system can be accessed on the Contra Costa Health Plan website, www.contracostahealthplan.org. Once on the website, you would click on the Provider Directory link which is on the menu, at the left side of the screen. Users then may click on "Find a Provider", "Search by Facility", or "Find a Pharmacy" to begin their search. Searches are driven by zip codes or provider name. Searches driven by zip code will locate providers closest to the zip code that's been entered. Gender or language specific searches are also possible search options.

Provider information has always been available, but not accessible in this way. The OSE unlocks this information and displays it in a user-friendly format that is easy to read and understand. Search results list detailed information about the Provider, such as their board certification, gender, office hours, location, telephone numbers, network affiliation and languages spoken by the office doctor/staff. All searches allow the user to print out the results of their search in an efficient PDF format. The OSE system is also fully integrated with Google Maps. This allows users to easily find directions to their destination by driving, public transit or by walking.



The OSE is in phase one of a two-phase solution. Not only has the OSE made accessing Provider, Pharmacy and other Facility data easier, it will also enhance and streamline the printed directories and pharmacy data in our Member Informational Materials. Both of these technologies were brought to Contra Costa Health Plan with no additional funding increases. The OSE will be available by Dec. 17, 2008.

Pharmacy & Therapeutics Meeting Update

The Pharmacy and Therapeutics committee at CCHP reviewed the efficacy, safety, cost and/or utilization of the following therapeutic categories/medications at the December 5, 2008 meeting. The changes should be effective on approximately January 20, 2009.

Histamine-2 Receptor Blockers	Pravachol®(pravastatin)	Simcor®(niacin/simvastatin)
Cymbalta®(duloxetine) PA criteria	Gleevec®(imatinib) PA criteria	Revlimid®(lenalidomide) PA criteria

The committee ***approved & added the*** following to the Preferred Drug List (formulary):

- ◆ Pepcid®(famotidine) Chewables and Pepcid®(famotidine) Tablets
- ◆ Pravachol®(pravastatin) 80mg (previously required use of two 40mg tablets)
- ◆ Simcor®(niacin/simvastatin)

The following were reviewed and ***prior authorization criteria*** approved or updated (remain non-formulary):

- ◆ Cymbalta®(duloxetine)
- ◆ Gleevec®(imatinib) and Revlimid®(lenalidomide) PA criteria are pending review by CCRMC oncology

FYI/REMINDERS:

Our formulary/Preferred Drug List is available online at iSite, CCHP's website at http://www.cchealth.org/health_plan/pdl.php, and electronically for download at www.epocrates.com for those with a PDA (personal digital assistant). Instructions for downloading the free CCHP formulary thru EpocratesRx® software can be found at <http://www.epocrates.com>. Please note that currently, EpocratesRx software is available for the Palm®, Win Mobile®, iPhone®, BlackBerry®, and Win Smartphone® PDA platforms. Please note, the user will need to register with Epocrates® before downloading the application.

At P&T, the committee also discussed a non-mandatory Crestor®(rosuvastatin) to generic statin switch program. CCHP plans to send letters to providers in the next few weeks further describing the switch. CCHP is asking that providers consider switching patients on lower doses of Crestor® to a generically available statin alternative. Only those providers with patients on lower doses of Crestor® will receive a letter asking them to consider a change.

SelectCare News

SelectCare is a Medicare Advantage Special Needs Plan offered by Contra Costa Health Plan. It is designed for Medicare beneficiaries who are also enrolled in the California Medi-Cal program. For our providers that manage *SelectCare* enrollees, we will provide updates on formulary issues through this provider newsletter. As of October 2008, no updates to the *SelectCare* formulary have occurred.

Two Plan Model Update for Contra Costa County

After many months of uncertainty, the Department of Health Care Services (DHCS) announced that Anthem Blue Cross rescinded their termination of the Medi-Cal Managed Care Plan. The Anthem Blue Cross termination would have affected the healthcare services for thousands of Contra Costa County Medi-Cal beneficiaries. DHCS has not yet received formal notification of the Anthem Blue Cross decision, but felt confident enough to notify the five affected county plans. CCHP is the plan in Contra Costa County that would have been impacted. The other plans are located in Alameda, San Francisco, Santa Clara, and San Joaquin counties.

Anthem Blue Cross has decided to terminate their participation in the Healthy Families Program, a state sponsored program, in Contra Costa County and four other Bay Area Counties. This termination will affect a few thousand low-income children in Contra Costa County beginning February 1, 2009. Healthy Families members will have three options in Contra Costa County: CCHP, Kaiser and HealthNet.

Utilization Management Department

Under the direction of the Medical Director, CCHP's Utilization Management Department (UMD) is responsible for managing resources to maximize the quality and cost effectiveness of the care provided to members. The UMD promotes positive member-physician relationships within the continuum of the health-care delivery system, while providing appropriate health care services. The UMD consists of three comprehensive integrated units: Authorization, Utilization Review, and Case Management.

♦ Florence Chan, RN, MBA, CCM, CPUM

Leading this department is Florence Chan. She has been a registered nurse since 1987. Before earning her RN license, she worked as an LVN for 5 years. She earned an Associate Degree in Nursing in 1986, a Bachelor of Science in Nursing in 1990, and most recently, a Master of Business Administration in 2006. As a Bay Area native, her practical RN experience includes positions at Highland General, Stanford and O'Connor Hospitals. Her interest in UM began in 1990 and she has since held a variety of utilization management and managed care positions. Before joining CCHP in 1999, Florence worked as a Case Manager and Utilization Review Coordinator at Santa Clara Valley Medical Center and Pacific Health Care. Her background in these roles enables her to function as the Director of Utilization Management and Case Management Services. Florence is a Certified Case Manager and Certified Professional in Utilization Management.

♦ Laurie Crider, RN, CCM

Laurie Crider is the Manager of Case Management Services. She received her BSN in 1984. She spent the first 14 years of her career as a Labor and Delivery and high-risk perinatal RN in New York and then at John Muir Medical Center in Walnut Creek. While at John Muir she also taught prenatal education classes and CPR. In 1989, Laurie earned her advanced certification in in-patient obstetrics. In 1998, Laurie entered the world of Managed Care when she became the Regional Manager of Women's Health at Aetna, Inc. She managed both their maternity case management program and the infertility program for the western half of the U.S. Having been "well challenged" by the California Managed Care system for 5 years, Laurie decided to update her clinical skills by becoming a home health RN for John Muir Home Health. The knowledge gained during this time in her career was invaluable when she became a UM/case management nurse at CCHP in 2004. She most enjoys seeing the positive impact that she and her amazing staff have on the health and well being of our most needy members. In 2006, Laurie earned her Certification in Case Management.

♦ Diane Doran, RN, CCM

Diane Doran is the Manager of the Authorizations Unit (AU). She has been a RN since 1987, graduating from Santa Monica College with an AS Degree in Nursing. Diane has worked in many areas of nursing: orthopedic and general surgery, pediatric and adult home health, AIDS hospice care, medical office supervision and rural nursing in Texas. Her experience also includes 7 years supervisory experience at John Muir Health in the UM Department. Diane came to CCHP in 2004. In February 2008, Diane became the Manager of the Authorizations Unit. Diane manages the day to day activities of the AU, focusing their efforts on the goal of excellent care and service to the community. She also handles all pediatric inquiries and authorizations, is the California Children's Services liaison for CCHP, and reviews and prepares services and claims appeals for presentation to the Appeals Committee. 
