Adult Committee (May 26th Meeting - Canceled)

Innovation Committee (May 25th Meeting - Canceled)

- The regularly scheduled meeting for May 25th was canceled due to the Memorial Day Holiday.
- The next meeting is scheduled for Monday, June 22nd from 2:30 pm to 4:00 pm. Location is tentative depending on the shelter in place restrictions. If lifted, it will be held at 1220 Morello Avenue, Suite #100, Martinez. Otherwise, it will be scheduled on Zoom.

Mental Health Commission (MHC) (May 6th – Online/Telephone Meeting)

- BHS is now a remote delivery system with 76% of services are offered via telephone or telehealth (video); the clinics are still open and fully functioning.
- BHS was allocated hotel/motel rooms to move homeless with mental illnesses off the streets.
- The financial outlook for the programs, including MHSA funds, is cautious as all services depend on the tax-based dollars – the reduction is expected; however, will do the best to keep current services untouched.
- Motions passed to ask BOS to support certain initiatives to help with the negative economic impact.

Quality of Care Committee (MHC QC) (May 21st – Online/Telephone Meeting)

- Went over three previous Program and Fiscal Reviews – more emphasis is needed around housing and for the CBO to work together.
- Update on the financial situation – D. Dunn can update CPAW at the meeting.

Reducing Health Disparities (RHD) (May 18th – Online/Telephone Meeting)

- The RHD Meeting Group reviewed the BHS Community Survey that will be sent to communities for feedback along with some input to implement some specific COVID-19 impact related questions.
- An update was provided on the taskforce for Marginalized Communities, as well as a review of the Contra Costa County Coronavirus/ COVID-19 data dashboard, with attention to demographic information. The group also provided some suggestions on training for the upcoming year.
- Next regular RHD Meeting will take place Monday, June 22nd from 1pm to 2:30pm, tentatively scheduled via WebEx.

Social Inclusion (May 14th - Online/Telephone Meeting)

- The committee held its first-ever virtual meeting via Zoom in collaboration with Putnam Clubhouse, whose staff presented on the virtual community that they are currently facilitating during the COVID-19 shelter-in-place. Other resources for maintaining social connectedness were also discussed.
- Hillary Bowers, NASM Certified Personal Trainer, facilitated a virtual fitness session including simple stretches and exercises.
- The committee engaged in a conversation about stigma and discrimination within the parallel contexts of behavioral health and COVID-19. Emphasis was made upon how individuals and groups in either context are unfairly targeted resulting in harm to the greater community.
- The next Social Inclusion meeting will be Thursday, June 11th from 1:30 to 3:30 PM and will be facilitated once again via Zoom.
